Fire Fighting	When silica dust is dispersed in air, firefighters should wear inhalation protection as hazardous substances from the fire may be adsorbed on the silica particles.
Extinguishing Media-	When heated to extreme temperatures, (>1700 °C) amorphous silica can fuse. Alert Fire Brigade and tell them location and nature of hazard. # **SECTION 11 TOXICOLOGICAL INFORMATION**

Information on toxicological effects

Inhaled	The material can cause respiratory irritation in some persons. The body's response to such irritation can cause further lung damage. Inhalation of dusts, generated by the material during normal handling, may be damaging to the health of the individual. Persons with impaired respiratory function, airway diseases and conditions such as emphysema or chronic bronchitis, may incur further disability if excessive concentrations of particulate are inhaled.
